## Privacy Policy

JobsOhio (also referred to as “us”, “we” or “our”) is committed to safeguarding the privacy of those who use our website. JobsOhio seeks to ensure its high standards for data privacy extend to everyone who uses our website from any place in the world, and that this policy is simple and clear to understand.

JobsOhio will not sell, rent, share or otherwise disclose your personal data to anyone, except as necessary to provide our services or as otherwise described in this Policy, without first providing you with notice and the opportunity to consent.

### Who Does This Policy Include?

- Individuals (also referred to as “users”, “your” or “you”) who visit our website.
- Find Your Ohio, a website hosted by JobsOhio.

### Who Does This Policy Exclude?

- JobsOhio’s website links to Innosource’s application service page where it collects applicant information. It is not the subject of this Privacy Policy. We recommend you read Innosource’s Privacy Policy.
- Further, JobsOhio’s website links to third-party websites that are not the subject of this Privacy Policy. We recommend you read the Privacy Policies of any third-party websites that you visit.
- JobsOhio’s website is not intended for individuals under the age of 18. As such, we will not knowingly collect personal data from any person under the age of 18.

### Types of Data JobsOhio Collects, Stores And Uses

- Name
- Job Title
- Company name
- Company address
- Personal and company phone and fax number(s)
- Email address
- Internet protocol (IP) address

### How This Information Is Used

- To build marketing profiles
- To aid strategic development (e.g. If JobsOhio advertises on weather.com, we track when you click on JobsOhio’s website from that site. If JobsOhio does not get any traffic from weather.com, we may stop advertising on weather.com.)
- To audit usage of the website
- To track whether users open emails from JobsOhio
- To receive periodic mission-related communications from JobsOhio and the JobsOhio Network.



## **Cookies**

On the JobsOhio website, you now have to opt-in to cookies. Cookies are small text files that can be used by websites to make a user's experience more efficient. Applicable law states that we can store cookies on your device if they are strictly necessary for the operation of our site. For all other types of cookies, we need your permission.

Some cookies are placed by third-party services that appear on our page. JobsOhio uses cookies to personalize content and advertisements, to provide social media features and to analyze traffic to our website. We also share information about your use of our site with our marketing vendors who may combine it with other information that you have provided to them or that they have collected from your use of their services. JobsOhio uses the following cookies:

- Necessary cookies help make a website usable by enabling basic functions such as page navigation and access to secure areas of the website. The website cannot function properly without these cookies.
- Statistic cookies help website owners understand how visitors interact with websites by collecting and reporting information anonymously.
- Marketing cookies are used to track visitors across websites and for remarketing efforts. The intention is to display ads that are relevant and engaging for the individual user and thereby more valuable for publishers and third-party advertisers.

You can configure your web browser to refuse cookies or to notify you when a website attempts to send you a cookie. You can also check your hard drive for cookie files and delete them from your computer. If you disable cookies, you may find a certain section of the JobsOhio website does not work properly.

## **Your Rights**

We will collect and process your personal data only when we have 1) your consent to do so; 2) an agreement in place with you or your company; 3) a legal obligation to do so; 4) another legitimate business interest or 5) to protect your vital interest or that of another person.

Please note your consent is for JobsOhio and its sales and marketing vendors, and the JobsOhio Network (JON) and their sales and marketing vendors. The JON is comprised of the six independent regional partner organizations: REDI Cincinnati, Team NEO, Dayton Development Coalition, Regional Growth Partnership, One Columbus, and Ohio Southeast for Economic Growth. JobsOhio has agreements with each of these entities that are compliant with the General Data Protection Regulation (GDPR).

Where we rely on your consent to process your personal data, you have the right to withdraw consent at any time. Where JobsOhio relies on a legitimate interest to process your personal data, such as an agreement with JobsOhio, you have the right to object. Your rights also include the right to access, correct, update, export or delete your personal data. You may email [privacy@jobs-ohio.com](mailto:privacy@jobs-ohio.com) with any request, and we will respond within 30 days. Subject to any exemptions provided by law, if you exercise your right to be forgotten, your personal data will be deleted from JobsOhio's systems, and you will receive written confirmation of the deletion. JobsOhio will also notify the JON and JobsOhio's vendors of your request and direct them to also delete your personal data.

JobsOhio may disclose your information to business partners or third-party data processors in accordance with a properly-executed court order or as otherwise required by law. JobsOhio will fully cooperate with law enforcement or a court order requiring it to disclose the identity or usage details of any user of our website.

**Log Data**

A JobsOhio vendor collects information that your browser sends whenever you visit our website ("Log Data"). This Log Data may include your computer's IP address, browser type, browser version, the pages of our website that you visit, the time and date of your visit, the time spent on those pages and other statistics.

**Security**

JobsOhio has commercially-appropriate measures in place to ensure user information is protected against unauthorized access or use, alteration, unlawful or accidental loss or destruction. We also have systems in place to authenticate, monitor, audit and encrypt your information. Nevertheless, no method of transmission over the Internet or method of electronic storage is 100% secure, and we cannot guarantee that information in our care will be absolutely safe from intrusion by others. It is important that you protect against unauthorized access to your account information and your computer.

**Transfer of Data**

Using the Internet to collect and process information about you may involve the transmission of data internationally. Therefore, by browsing JobsOhio's site, you acknowledge and agree to the processing of your information in this way. By agreeing to JobsOhio's transfer of your information to third parties, you are deemed to have consented to any transfer of your information to a third party that JobsOhio works with outside the European Union.

**Revisions**

By visiting the site, you are legally bound by the terms of this policy. JobsOhio reserves the right to revise, update or change the terms of this Privacy Policy at any time without prior notice to you.
